


DELIVERY CONVEYOR

- 53' x 36" conveyor with 20 HP electric drive (350 FPM)
- 12" self cleaning wing pulley
- Belting is 220 PIW, 1/8 x 1/16 cover
- Primary belt cleaner with internal spring tensioner

FINES CONVEYOR

- 43' x 60" conveyor with 15 HP electric drive (350 FPM)
- 12" self-cleaning wing pulley
- Secondary belt cleaner with internal spring tensioner
- Belting is 220 PIW, 1/8 x 1/16 cover

CHASSIS

- 21" I-Beam with king pin type hitch
- Twelve (12) 11 R22.5 tires and mud flaps
- Leaf spring suspension, air brakes, rear tail lights

VIBRATING SCREEN(1)

- One (1) 2612D double deck PEP Duo-Vibe® dual frequency screen
- 5' x 10' scalping screen top deck
- 6' x 12' high-frequency screen bottom deck
- Top deck driven by 1200 RPM vibrating mechanism mounted on screen
- Bottom deck driven by five (5) variable speed hydraulic vibrators (0-4200RPM) mounted below screen for directly induced vibrating action
- All vibrators have five (5) force amplitude settings on adjustable slip counterweights
- Hydraulic controls for variable angle operation
- Fines collecting hopper
- Top and bottom deck discharge chutes
- Access ladder with step type walkways and handrails for both sides of screen

VIBRATING SCREEN(2)

- One (1) triple deck 6' x 20' flat screen; Oval stroke motion
- Drives, guards; Adjustable stroke and speed; 40 HP drive package
- Step type walkways and handrails for both sides of screen
- Top, middle and bottom deck discharge chutes
- Less screen cloth (top, middle and bottom deck side tension)

One primer coat, finish coat of KPI Beige

OPTIONS

- Standard Steel Screen Cloth for 2612D
- Standard Steel Screen Cloth for triple deck screen
- 5th Product Conveyor
 - (11' x 24" side discharge conveyor to be mounted below 2612D fines hopper and allows customer to produce a 5^{th} product)
- Hydraulic Leveling

(Eight (8) hydraulic leveling jack system; two (2) 4-bank valves, gasoline power unit; swivel shoe, check valve with stiff leg mechanical lock) • Side Conveyors

(Three (3) 11' x 24" roll out conveyors with electric drive (0-280 FPM); Reversible direction; 12" rubber lagged 5 HP motorized head pulley Primary belt cleaner with internal spring tensioner; Belting is 220 PIW, 1/8 x 1/16 cover)

 (NEMA-4 electrical enclosure; 100 and 200 amp disconnects; Starters to run all electrical motors on plant; five (5) additional size #2 starters to run stacking conveyors from all product conveyors on plant; 110 volt outlet; MSHA approved warning horn for startup; Emergency stop button)
